The licensee must:- 牌照持有人必須: -

- (a) display this licence in a prominent position inside its principal place of business,在其主要辦事處的當眼處,展示本牌照;
- (b) only supply individuals to perform the type of security work as specified in this licence; 所提供的員工只能從事本牌照所註明的該類保安工作;
- enter its name and the period of employment on the permit of security personnel under its employ; 在其僱用的保安人員的許可證上,填上其姓名人及受僱年期;
- (d) notify the Commissioner of Police in writing of:- 若出現下列情况,即:-
 - (i) any criminal proceedings against the controller(s), directors and executives, and all security personnel permit holders of the company within 14 days after the licensee has become aware of the institution of such proceedings; 公司控制人、董事、行政人員,以及任何持有許可證的保安人員一旦遭受刑事檢控,則公司持牌人須在得知這些行動的十四日內,以書面通知警務處處長;
 - the name of the persons whom it employs to do security work and the date on which the employment commenced within 14 days after the commencement of the employment; and 須在所屬人員開始受僱日起計十四日內,把受僱擔任保安工作的人員姓名及開始受僱日期以書面通知警務處處長;及
 - (iii) the name of the persons whom it ceases to employ to do security work and the date on which the employment ceased within 14 days after the cessation of the employment. 須在所屬人員終止受僱日起計十四日內,把終止受僱擔任保安工作的人員姓名及終止受僱日期,以書面通知警務處處長。
- (e) not act contrary to the requirements of its work as a security company. 不得違反保安公司的工作規定

- (f) Installation, maintenance and repairing of intruder alarm, access control and CCTV devices. 安裝、保養及修理防盜警鐘、通道管制及閉路電視等裝置。
- (g) Designing a security system incorporating intruder alarm, access control and CCTV devices. 設計附有防盜警鐘、通道管制及閉路電視等裝置的保守系統。
- (h) The licensee must inform the Security and Guarding Services Industry Authority and the Commissioner of Police for follow up inspection on first employment of Security Personnel Permit holder technicians, and before the commencement of supplying individuals to do security work. 持牌人開始聘用持有保安人員許可證的技術員時,以及開始提供人員執行保安工作之前,必須通知保安及護衞業管理委員會和警務處處長,以便安排進一步視察。
- The licensee must demonstrate to the Security and Guarding Services Industry Authority and the Commissioner of Police that it has adequate Public Liability and Employees Compensation Insurance before supplying individuals to do security work. 持牌人在提供人員執行保安工作之前,必須向保安及護衞業管理委員會和警務處處長證明,已購買足夠的公眾責任及僱員補償保險。
